Measures related to the transport of certain agricultural products from Ukraine - supplement

Dear Customer,

We hereby inform you that, pursuant to Government Decree No. 130/2023 (IV.18.) of the Government of Hungary on measures related to the transport of certain agricultural products originating from Ukraine (hereinafter referred to as "Government Decree"), our Company introduces a restriction on the trade of products (hereinafter: TR (Transport Restriction on Carriage)) with the content available on our website by Nr. 23 172. According to this, **our company does not accept imports from Ukraine, sensitive products defined in the Annex to the Government Decree (see attachment).**

Transit consignments arriving on normal wagons will be forwarded to the consignee in the usual way after official inspection and sealing, provided that they have our Company's prior authorization as described in the TR.

However, we are able to accept transit shipments arriving on wide wagons, but only with a valid authorization from rchun_uzemiranyito@railcargo.com.

The government decree justifies the measure below:

According to the restriction, "during the state of the emergency, the products specified in Annex 1 (hereinafter referred to as sensitive products), with the exception of transit shipments as provided for in § 2, may not be brought into the territory of Hungary if they originate from the territory of Ukraine."¹ Furthermore, "the carrier of the sensitive products shall certify that the products transported on the means of transport do not originate from the territory of Ukraine. In doing so, the customer's declaration alone cannot be taken into account to prove the origin of the sensitive products."²

The restriction does not apply "to a consignment which is imported into the territory of Hungary for transit purposes on the basis of a declaration by the carrier and which leaves the territory of Hungary by the end of the seventh day following the day of import."³

"The restriction on imports into Hungary is of a temporary nature and shall expire on 30 June 2023..."⁴

Transit consignments shall be sealed by the National Tax and Customs Office; it shall be the responsibility of the carrier to ensure that the seal remains intact during the transport. In addition, when the official seal is affixed, a record must be kept of the important information relating to the consignment.⁵

In view of the situation, we ask for your kind understanding and cooperation.

We will inform our partners as soon as we have any new information.
