

Data Processing Notice
concerning the data processing related to the RCG Partner Event on 14 November 2024

Rail Cargo Hungaria Árufuvarozási Zártkörűen Működő Részvénytársaság (Registered office: 1133 Budapest, Váci út 92., Company registration no.: 01-10-045318, VAT number: 13594567-2-44, hereinafter referred to as the "**Data Controller**", the "**Company**") hereby submits this information notice (hereinafter referred to as the "**Data Processing Notice**") in order to comply with its information obligations under Regulation 2016/679 of the European Parliament and of the Council of 27 April 2016 *on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC* (hereinafter "**GDPR**") in connection with the processing of personal data concerning the organisation and hosting of the RCG Partner Event (hereinafter referred to as the "**Partner Event**") held at Park Inn by Radisson Budapest hotel (1138 Budapest, Szekszárdi út 16-18.) on 14 November 2024 for the benefit of the Data Controller's business partners, and in connection with the taking of photographs.

The Data Controller informs the data subjects that the concepts and principles of data processing, as well as more detailed regulations related to the security of data processing and more detailed information and contact details related to the exercise of the data subjects' rights under the GDPR are set out in the Data Controller's Privacy Policy, the current version of which is available at the Data Controller's registered office.

Taking into account that the Data Controller is entitled to prepare a separate extract for each of its processing operations, the content of which may provide prior information to data subjects in the context of specific processing of their personal data, the Data Controller has prepared this Privacy Notice.

2. Data processing related to the Partner Event

2.1. Data processing concerning the applications for the Partner Event

Aim of the data processing:	Contacting necessary for the participation at the Partner Event
Processed data:	Name, phone number, e-mail address, company name
Data subjects:	Applicants for the Partner Event
Legal basis for the data processing:	Consent of the data subjects according to GDPR Article 6 (1) a)
Termination of data storage:	Until the withdrawal of the data subjects' consent, but no later than one year after the application date.

Method of data processing:	Electronic management.
Source of data:	Record of data subjects' information
Possible consequences of not providing the data:	The provision of personal data is a condition of participation at the Partner Event, so if the data subject wishes to register for the event organised by the Company, the provision of the data is mandatory.
Automated decision-making and profiling:	The Company does not use automated decision-making and profiling.
Who can access personal data?	Colleagues of the Company's Marketing and Sales Departments.
Transfer of data to third countries or international organisations:	Transfer of data to third countries or international organisations does not take place.

Termination of data storage	Until the withdrawal of the data subjects' consent.
Method of data processing	Electronic management.
Source of data	Record of data subjects' information
Automated decision-making and profiling	The Data Controller does not use automated decision-making and profiling.

Transfer of data to third countries or international organisations	Transfer of data to third countries or international organisations does not take place.

3. Data processors, data transmission

The Data Controller informs the data subjects that the Data Processors are not entitled to take independent decisions, they are only entitled to act in accordance with the contract concluded with the Data Controller and the instructions received. The Processors shall record, process or handle personal data transmitted to them by the Controller and processed or handled by them in accordance with the provisions of the GDPR. Processors shall carry out processing operations on the personal data provided by data subjects within the available period of use indicated in this Privacy Notice, in accordance with the specific purposes of the processing. The Data

Controller shall not use a data processor in connection with its processing under this Privacy Notice and shall not transfer the data to third parties.

4. Rights of the data subjects and legal remedy

The data subject may request information about the processing of his or her personal data; the rectification of his or her personal data; the restriction of processing; the erasure of his or her data by contacting the Data Protection Officer of the Controller or by written request sent to the Data Controller's headquarters; and the right to object to processing, as well as the right to data portability and the right to a judicial remedy and to withdraw consent.

If the data subject considers that the processing is in breach of the provisions of the GDPR or the Information Act, or if the data subject considers that the processing of personal data by the Controller is prejudicial, the data subject may lodge a complaint with the Controller, and the data subject may also lodge a complaint directly with the authority regarding the processing of personal data by the Controller, or lodge a complaint with the National Authority for Data Protection and Freedom of Information (address: 1055 Budapest, Falk Miksa utca 9-11., postal address: 1363 Budapest, Pf. 9., phone number: +36 (1) 391-1400, e-mail: ugyfelszolgalat@naih.hu, website: www.naih.hu). To protect their data, the data subject has the right to apply to the courts, which will rule on the case out of turn. In this case, the data subject is free to decide whether to bring its action before the courts for the place where it resides (permanent address) or where it is staying (temporary address) (<http://birosag.hu/torvenyszekek>).
